

## Millennium

### Program Description

Millennium is a fully systematic, multi-model trend following program that manages capital across a diversified portfolio of 42 exchange-traded futures markets. Market sectors traded include interest rates, currencies, grains, softs, metals, meats and energies. The program employs 22 models which have a long and ultra-long term focus. The use of both trend and counter-trend components in the models lowers the correlation of Millennium to other trend following systems. Each model consults a "Fuzzy-Logic Trend Filter" for permission to initiate positions and to take on market risk.

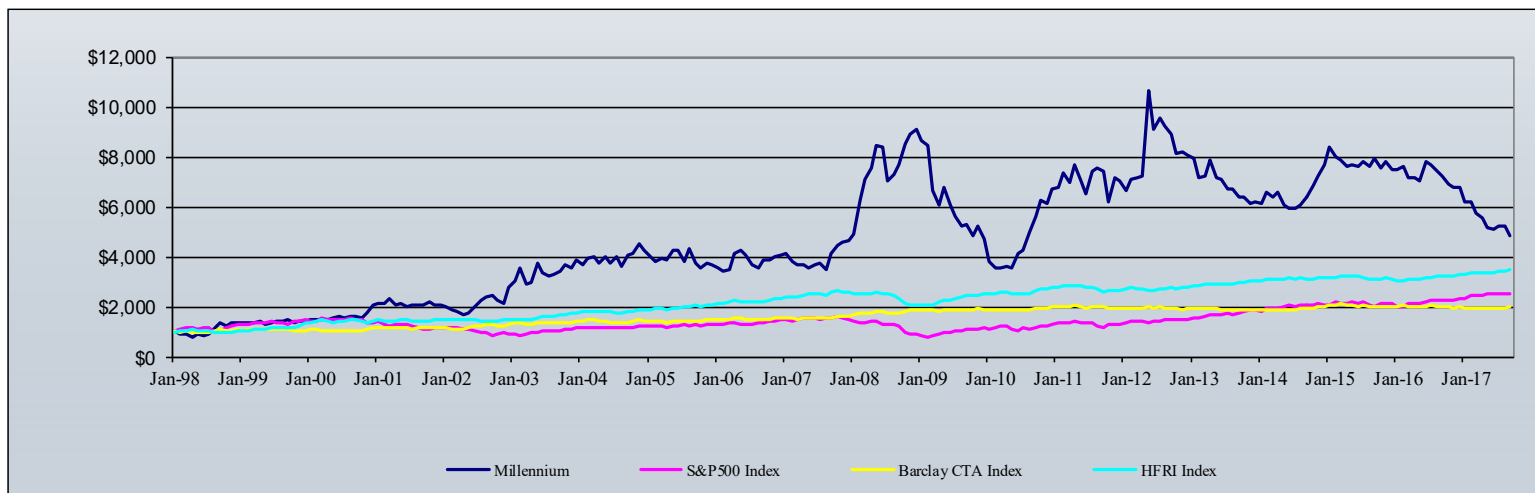
